

## Terms and Conditions for Jeta FX

### 1. Acceptance of Terms

- **For withdrawals of ₹10,000 or less:** Processing will occur within **24 hours**.
- **For withdrawals exceeding ₹10,000:** Processing will occur within **48 hours**.

Withdrawal timelines are subject to verification of trading activity and account compliance.

## Minimum Trade Volume for Withdrawals

To initiate a withdrawal, the following minimum trade volumes must be met based on your account type:

- **Pro Account:** Minimum of **1 trade** must be executed.
- **Premium Account:** Minimum of **2 trades** must be executed.
- **Zero Account:** At least **1 lot** must be traded.

Failure to meet the above trading volumes may result in withdrawal requests being delayed or denied.
